What PM Modi does is agreement with Australia, aspiring to do an agreement with the EU, UK, US, New Zealand, Oman, Bahrain and Qatar, because we want to compete with the best of the world," he said.



These tariffs on India products may not be in place for long as the country hopes to conclude a Bilateral Trade Agreement (BTA) with the US soon, one official told ET.

The stock market took the development in stride — the Sensex declined 0.42% and the Nifty was down just 0.35%.

Economists said India's expected 6.5% growth in the current year could take a 30-60 basis point hit from the blow that exports will take and the spillover of slower global growth due to Trump's measures.

The US has imposed 10-57% tariffs against 57 countries, fulfilling his election pledge to complete a task he had begun in his first term. Of these, 33 face higher tariffs than India. Those countries that haven't been slapped with reciprocal tariffs face a baseline 10% levy.

Experts said the tariff calculation was based on the trade deficit and imports from each country and not the duty imposed by that country. The chart noted India's average tariff

at 52%, and America's "discounted" reciprocal tariff of 26%. White House documents, however, stated there will be a 27% additional duty on India. "Uncertainty will spiral and trigger



The US is the largest market for India's shrimp industry. The product will now become less competitive in the US market due to the higher tariffs relative to other exporting nations such as Ecuador. The US already has anti-dumping and countervailing duties on Indian shrimp.

In carpet exports, India will lose out to Turkey. FIEO said the duties pose a challenge but India is better placed than competitor nations as their goods would face higher taxes.

Gems and jewellery exporters termed the tariffs a major setback and urged the government to take steps to secure the

long-term interests of the sector. Steel industry executives said India will become more vulnerable to low-cost imports as the countries impacted may di-

vert their shipments to the local market. The Association of Indian Medical Device Industry (AiMeD) said exports may pose challenges to the sector's growth

due to the additional taxes. India's key exports to the US included rug formulations and biologicals (\$8.1 billion), telecom instruments (\$6.5 billion), precious and semi-precious stones (\$5.3 billion), petroleum products (\$4.1 billion), gold and other precious metal jewellery (\$3.2 billion), ready-made garments of cotton, including accessories (\$2.8 billion), and pro-

ducts of iron and steel (\$2.7 billion). "Net-net, it appears India's export competitiveness to the US market stands far less impacted on a relative basis," said Assocham president Sanjay Nayar. "Yet our industry should make concerted efforts to increase export efficiency and value addition, to mitigate impact of these tariffs.'

Then there is Guadeloupe, Martinique and French Guiana all of which are territories of France and part of the European Union. Each of these have attracted the baseline tariff, and all EU would need to avoid the 20% tariff imposed by Trump is to route trade via any of these territories—a convenient little loophole.

The next one is the clincher. There are a couple of countries in the Pacific-Micronesia and Marshall Islands-which are signatories to an agreement known as the Compact of Free Association. Under this, the US provides defence support, funding grants and even access to US Social Services, in effect making them overseas territories for America. The White House has slotted both right into the 10% tariff list.

Is there a method to the seemingly endless randomness of the tariff numbers? Here's how the tariffs were calculated. The White House took the trade deficit in goods

with various countries, divided it by goods imported from the nation, and then divided the outcome by two. For those with whom the US runs a trade surplus, the tariff was, rather inexplicably, levied at a baseline 10%.

What explains the tariffs in the first place? The lopsided global trade balance with China on one side and the rest of the world on the other was what some on X pointed out as the reason for Trump's moves. But as James Surowiecki, author of The Wisdom of Crowds, pointed out, "If China is the problem, Trump should be tar

geting China. What he did today targets the entire world." There are details aplenty making the 'plan' that emerged yesterday even stranger. Ecuador was slapped with a 10% tariff and was dubbed a currency manipulator. Except for one small detail 1—Ecuador, since 2000, has used the US dollar as its currency.





Bolivia deports Nithyananda followers

olivia recently arrested and deported 20-odd people associated with the nonexistent country 'United States of Kailasa' - 'founded' by fugitive godman Nithyananda, who had fled India in 2019 after being accused of rape, torture and child abuse - accusing them of "land trafficking" after they negotiated 1,000-year leases with indigenous groups for swaths of the Amazon three times the size of New Delhi. Officials said the deals were declared void, and the 'Kailasans' were deported to their actual home countries, among them India & the US.

'Kailasa' did not respond to requests for comment. Scandal erupted after a Bolivian newspaper exposed the leases. A leader of the Baure, one of the groups, said its contact with 'Kailasa' emissaries began late last year, when they arrived offering help after forest fires. Subsequently, land leases were proposed and the Baure agreed to a 25-year deal that would supposedly have paid them nearly \$200,000 annually. But when 'Kailasa' representatives came back with a draft in English, it covered 1,000 years and included use of airspace and extraction of natural resources. "Is the govt siding with the unqualified?" he asked. TNN

SFIO charges Kerala CM's daughter with corporate fraud

T'puram: The Serious Fraud Investigation Office (SFIO) has filed a chargesheet naming Veena T, daughter of Kerala CM Pinarayi Vijayan, in the CMRL payoff case.

She has been accused by SFIO, which functions under ministry of corporate affairs, of fraudulent transactions amounting to Rs 2.7 crore in the case in the form of alleged monthly payments to her from Kochi-based Cochin Minerals and Rutile Ltd.

The chargesheet, filed in a trial court in Delhi, also names CMRL MD Sasidharan Kar-

tha, director Anil Ananda Panicker, CFO Suresh Kumar, CGM P Suresh Kumar, and statutory auditors Sagesh Kumar K A and Muraleekrishnan A K. Meanwhile, Delhi HC refused on Thursday the mining firm's petition to stay SFIO probe.

SFIO claims its probe reveals that Veena T's company, Exalogic Solutions Pvt Ltd, received Rs 2.7 crore from CMRL without providing any legitimate service. The payments were allegedly routed through CMRL and Empower India Capital Investments Pvt Ltd, a company linked to Kartha's family. The chargesheet states that these payments had no valid business justification, making them a violation of corporate fraud laws.

The accused have been charged under Companies Act, 2013 Sect 447, which deals with corporate fraud. If convicted, they face minimum imprisonment of six months and a maximum of 10 years. Additionally, they could be fined an amount not

less than what is involved in the fraud, and up to three times that sum. If the court determines that the fraud involves public interest, the minimum jail

term goes up to three years. SFIO says its investigation also exposed wider financial irregularities at CMRL amounting to Rs 182 crore. Investigators found that expenses were misreported under sludge handling & trans-

portation costs, while Rs 13 crore was allegedly paid in fraudulent commissions to Panicker. The transactions were allegedly carried out through firms linked to Kartha's family. These entities were allegedly used to inflate expenses, fabricate bills and siphon off company funds.


